CODE OF CONDUCT

This Code of Conduct is established in accordance with the objectives of the Poppy Estate Senior Men's Golf Club, (the Club). In order to make the Club's activities enjoyable for all members, the Executive Committee expects members to adhere to a set of guidelines known as the Code of Conduct. Members are expected to not only observe the letter but also the spirit of the Code of Conduct, its ethics, and ideals, thus giving true significance to the aims and objectives of the Club.

The Club is a non-profit group governed by an elected Executive Committee. The members of the Committee are volunteers who strive to provide the membership with a friendly competitive atmosphere in their weekly golf games.

The responsibilities of the Executive include, but are not necessarily limited to the following:

- a) Serving all members faithfully and with integrity in all manners relating to the operation of the Club;
- b) Encouraging the highest principles of fair play between members;
- c) Managing the affairs of the club in a professional manner; and
- d) Maintaining a good and cooperative relationship with the management of the Poppy Estate Golf Course.

As a condition of membership, all members assume responsibility to observe standards of conduct and rules that will contribute to the betterment of the Club and the enjoyment of the game of golf. This may include, but is not necessarily limited to the following:

- a) Complying with the Policies and Procedures of the Club;
- b) Complying with the RCGA rules and the policies of the Poppy Estate Golf Course;
- c) Demonstrating respect for other club members and employees of the Poppy Estate Golf Course;
- d) Showing up for play at least 30 minutes before the scheduled tee time;
- e) Supporting the activities of the Club to the best of their ability;
- f) Accurately recording their golf scores and, after completion of the day's game, entering their scores in the Club's computer; and
- g) Promptly advising the pro-shop staff if they are not available to play at their reserved tee time on the "Sign-up Sheet";
- h) Should a member not adhere to (g) above, he will be considered a NO SHOW and, at the discretion of the Executive, will have the following penalties applied; **First Occurrence – Warning, Second Occurrence – Suspension for one month and, Third Occurrence – Removal of Member Privileges.**
